Indeed, in the case of a FAMILY Canine Pension, the Civil Liability insurance of the owner of the dog will not cover anything if the latter is not present at the time of the events. By signing this contract, responsibility for the dog is transferred to LA VILLA QUI A DU CHIEN©; the professional insurance of LA VILLA QUI A DU CHIEN©, on the other hand, only takes into account any damage caused by dogs to third parties, outside the boarding house. In the event of damage caused by a dog in La Villa, an amicable agreement on the amount that the owner will have to pay must therefore be preferred, as compensation. Thank you for your understanding.

## PRICES:

- 13 €/½ day; 18 €/1 day; 23 €/1 day + 1 night (from 9AM to 9AM D+1)
- 7 days + 6 nights pass = 140 €
- Extra charges for meals (if not provided by the owner):
  - o 6 €/day, small dog (<7 kg)
  - o 8 €/day, medium dog (<17 kg)
  - o 11 €/day, large dog (<32 kg)
  - o 14 €/day, very large dog (>32 kg)
- Drugs administration (**only on presentation of the vet's prescription**): extra charges of 1 to 5 €/day, depending on the frequency.
